- ITEM 7 CONSIDER AND TAKE ACTION TO APPROVE RESOLUTION NO. 24.04.08 ALLOWING MEMBERS, RETIREES, AND WIDOWS OF THE FRIONA VOLUNTEER FIRE DEPARTMENT TO RECEIVE A MONTHLY WATER UTILITY SERVICE CREDIT FOR SERVICES THAT PROTECTS THE HEALTH, SAFETY, OR WELFARE OF THE CITY

RESOLUTION NO. 24.04.08

A RESOLUTION OF THE CITY OF FRIONA, TEXAS, ALLOWING MEMBERS, RETIREES, AND WIDOWS OF THE FRIONA VOLUNTEER FIRE DEPARTMENT TO RECEIVE A MONTHLY WATER UTILITY SERVICE CREDIT IN AN AMOUNT NOT TO EXCEED \$120 FOR SERVICE THAT PROTECTS THE HEALTH, SAFETY, OR WELFARE OF THE CITY. **WHEREAS**, The City of Friona has a volunteer fire department that serves the community in fire protections; and

WHEREAS, Bi-Weekly training sessions are required by the State Fire Commission, thereby requiring much time and effort of the volunteer firefighters; and

WHEREAS, many of the firefighters have and will serve the city and community for over a twenty (20) year period.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FRIONA, TEXAS:

- SECTION 1: Active Firefighter: That persons that serve satisfactorily on the active force of the Friona Volunteer Fire Department shall be exempt, at the discretion of the Fire Chief, from paying the monthly water utility bill to the City if the use of water does not exceed the amount of \$120 for a monthly period.
- SECTION 2: Retired Firefighter: After serving a period of 20 years satisfactorily, a volunteer firefighter may retire and shall be exempt from paying a water utility bill to the City until an untimely passing.
- SECTION 3: Widow of Retired Firefighter: The widow of a retired firefighter shall continue to be exempt from paying a water utility bill to the City until an untimely passing or until they remarry.
- SECTION 4: This action only applies to residential water utility billing accounts.

BE IT FURTHER RESOLVED THAT THE CITY OF FRIONA CANNOT PROVIDE RETIREMENT BENEFITS TO MEMBERS OF THE FRIONA VOLUNTEER FIRE DEPARTMENT DUE TO THE FOLLOWING REQUIREMENTS OF THE TEXAS MUNICPAL RETIREMENT SYSTEM (TMRS):

- SECTION 1: Volunteers are not eligible to participate in TMRS because they are not employed by a TMRS participating city.
- SECTION 2: Members of TMRS must work more than 1000 paid hours per year to qualify for TMRS benefits.
- SECTION 3: The TMRS Act that governs the plan requires both of the abovementioned requirements.

SECTION 4: This resolution takes effect immediately and repeals Resolution No. 81.05.04

ITEM 8 CONSIDER AND TAKE ACTION TO APPROVE A PROFESSIONAL SERVICES AGREEMENT WITH THE TEXAS TECH UNIVERSITY SCHOOL OF VETERINARY MEDICINE REGARDING A FERAL ANIMAL CONTROL PROGRAM

Animal Control, Lupe Salinas, briefed the council regarding why an agreement with the Texas Tech University School of Veterinary Medicine would benefit the city by spaying feral cats.

MOTION Mayor Pro Tem Monroe made the motion to approve the professional services agreement with the Texas Tech University School of Veterinary Medicine regarding a feral animal control program and Council Member Moreno made the second to the motion. The motion passed with a 5/0 vote.

ITEM 9 DISCUSSION ON THE WATER REQUEST FROM ROBERT MCGEE WITH WEBER CONSTRUCTION REGARDING THE CARGILL OVERPASS PROJECT

Mike Oliver with Webber, LLC. briefed the council on the bridge project coming to Cargill. They are scheduled to begin moving dirt on April 15, 2024. The project is projected to take 2.5 years. The project will bring approximately 20 jobs. Mike Oliver will provide the city with the website for us to share the job postings with our community.
